Christian Burial at the discretion of My Executors Nothing doubting but at  
the general Resurrection I shall receive the same again by the Mighty power of  
God And as touching such Worldly Estate wherewithal it has pleased  
God to bless me in this life I give dispise and Disposse of the same in the  
Following Manner and soonest as much of my Estate as we will  
satisfy and pay all my Lawful Debts to be left at the discretion of my Executors  
what to sell Item I give and bequeath to Sarah my dearely belov'd wife  
all and every thing that I possess after my lawful debts is paid and after  
Sarah my Wif's Deceas I give and bequeath unto Jeremiah Glen and  
Thomas Glen my Sons the land whereon I now live and the Island  
land to be divided as followeth to begin at my flat landing and run  
due west course to the back line and my son Jeremiah Glen to  
have the upper end of the mid land and the Island land And Thomas  
Glen my son to have the lower end with the plantation affo after the  
Deceas of My wife Sarah all my Estate Shall be sold Except  
the before mentioned land and to be equally Dividet among all my  
Children Viz Suckey Duggey Jernmy & Thos Glen  
And if there shall be any thing remaining so left to me by me or my  
Wifes Parents shall it be also equally diuided among the  
above mentioned Children - And Thereby appoint William  
Bryant & Thomas Adams my sole Executors
