or waste, nor lend them without his Consent to any from the Service of the Said Smith shall not at any time, depart or Absent himself, without his said Masters leave, but in all things as a good faithfull apprentice shall and will Demean and behave himself towards the said Smith in all things during the said Term. And the said Smith the Said Apprentice, the Trade, science, or Occupation of a Planter which he now uses, with all things thereunto belonging, together with reading, and writing shall and will Teach and instruct or otherwise cause to be well and Sufficiently taught and instructed after the best way, and manner, that he can and shall and will also find and allow unto the said apprentice, Meat, drink washing, lodging, and apparell, both linnen, woolling and all other necessaries, in Sickness, and in Health, meet and convenient for such an Apprentice during the Term aforesaid and at the Expiration of said Term shall and will give to the said apprentice (over and above his then Clothing) three pounds proclamation Money, and One Sufficient Suit of wearing Clothes, as it fit and usual for such an Apprentice.
