THIS Indenture made this 8th day of March in the Year of our Lord 1783 Between Joel Lane Esquire Chairman and Presiding Justice of our said Court on behalf of himself as well as the Justices of the said Court of the One Part and David Lowry of the other Part Witnesseth that the said Joel Lane on behalf of himself and the rest of the Justices aforesaid hath put out and Bound George Chaves a free Negro Boy Apprentice to the said David Lowry, the said David Lowry to teach his said Apprentice the Art Mistery and Occupation of a Planter and further to teach or Cause to be In-

Instructed in Reading and Writing agreeable to his Degree and Agreeable to Law, and the said George Chaves is to Serve his Master well and faithfully untill he Attains the Age of Twenty one Years being on or about the Eighth day of March last of the Age of three Months during which time the said David Lowry shall provide and procure for his said Apprentice Sufficient Meat, Drink, washing, Lodging and Apparell both linnen and Woollen fit and Convenient for such an Apprentice and further to do and perform every Article and thing mentioned in an Act of General Assembly of this State in that case made and provided.
