Last Will and Testament of John Cannon dec^d

In the Name of God Amen I John Cannon of the County of Wake and province of North Carolina being in Sound Mind and perfect Memory but knowing that it is appointed for all Men Once to Die do make and Ordain this to be my last Will and Testament in manner and form following Vis. First it is my Desire that my Ex^r hereafter Named pay all my Just Debts, I also lend to my Beloved Wife Sary Cannon all my Land from my Son Archers field to W^m Walkers line during her Widowhood and I also lend as much of my Other Estate Yearly as my Executor shall think proper to Support her, all the Remainder part of my Land I give and bequeath to my beloved Son Archer Cannon and after the Widowhood or Death of my Wife I desire my Son Acher may have the other part of my Land and all the rest of my Estate, but what my Executor shall think Sufficent to Support my Wife. I do make this to be my last Will and Testament Revoaking all other Wills Testaments or Instruments of Writing of any Nature or Kind Whatsoever and hearby

Appointing Lodwick Alford Junior whole and Sole Ex-
ecutor of this my last Will and Testament. In Witness
