this 29 day of July A.D. 1766.

The condition of this Obligation is such that if the above bound Sarah
Johnson should diminish or take away any singular the goods & Chattels Rights & Credits
of Charles Johnson late of Bute County Dec'd do make or cause to be made or
have or perfect Inventory of all singular the goods & Chattels Rights & Credits
of the deceased which she or she should owe to the hands knowledg or possession
of the said Sarah Johnson or into the hands or possession of any other person or
person or persons or the same so made do exhibit or cause to be exhibited into
the

for Administration $\frac{1}{2}$ within 12 months after the date of these presents and
 the same goods Chattels & Debts & all other the Goods Chattels & Credits of the said
 at the time of his death which at any time hereafter shall come into the hands
 possession of the said Sarah Johnson in the hands or possession of any other person
 persons for her so well & truly Administrator according to law and farther to wicks or
 cause to be made a true & just Account of her said Administration within one year after
 the date of these presents and all the rest & effect of the said Statute & Statutes
 which shall be found & remaining upon the said Act & Statute, the same being first
 examined & allowed by the Governor & Council General but a County Court shall
 deliver & pay unto such person or persons respectively as the Court shall be duly
 pursuant to the true intent & meaning of the Act in that behalf made & provided, and if it
 shall appear that any Will or Testament was made by the said Deceased, and the Executor
 or Executors therein named do exhibit the same but not making it good to have
 it allowed & approved of accordingly, if the said Sarah Johnson above mentioned being
 her executor do require the Governor the Director of Administration, approbation
 of such Testament being first allowed in the said Statute then his Obligation to be
 void & to remain in force.
