Know all men by these presents that Lewis Bobbet of the County of Brunswick Province of North Carolina for & in consideration of the sum of twenty pounds Curr. money of Virginia to me in hand paid by Lewis Bobbet Junior of the same County at & before the signing of these presents the receipt whereof I do hereby acknowledge have bargained and sold unto the said Lewis Bobbet Junior & by these presents do bargain sell make over & deliver the following goods & Chattels to wit two Feather beds & furniture twenty head of Hogs being my whole stock market & unmarket wine hogs of cattle marked with my proper marks one Horse two chests one spinning wheel two Iron pots six pewter plates two pewter dishes three wedding Hoes two killing Hoes one plow hoe one grubbing hoe ten Hoes one man's saddle three stool traps three Chears one Table one Bridle one pair of Cotton cards one Tying pan seven pewter spoons one quart mug one Tin pot one gun four knives & forks two narrow Axes one Hatchet two pairs one washing Tub two Horse bells & four sides of Leather, and I the said Lewis Bobbet do by these presents warrant and defend the aforesaid goods and Chattels unto the said Lewis Bobbet Junior and to his assigns from the lawful claim or claims of any person or persons whomsoever and I the said Lewis Bobbet do by these presents further covenant and grant to and with the said Lewis Bobbet Junr for me my heirs Executors & assigns that I the said Lewis Bobbet am lawfully seized & possessed of the aforesaid goods & bargained promised & to every part & parcel thereof free & clear from all manner of Sales Mortgages or incumbrances of what nature
