without heir that then the abo^r v^d goods Chattels & Household stuff to fall unto Harri-
son Harris of the County & Province afo^r. from henceforth to his and his heirs proper use &
uses thereof & their heirs to do order & dispose at his or their wil^l & pleasure as of
their proper goods & Chattels free peaceable & quietly without any manner of Lett Trouble
or denial of me the S^d Samuel Dispain or any other person whatsoever of all which pro-
-wises I the S^d Samuel Dispain have put the S^d Benjamin Dispain & his heirs in full and
peaceable possession by virtue hereof In Witness whereof I the S^d Samuel Dispain have
herunto set my hand and Seal dated this the 2^d day of February 1767.
