In the name of God Amen I John Edwards Esq^r of Bute County in the Province of North Carolina being weak of Body but of sound disposing memory thank be to God but calling to mind the frailty of nature and the mortality of the body & that it is appointed for all men once to die do make & publish this my last Will and Testament in writing hereby revoking and disannulling all other former Will or Wills by me heretofore made and publishing & declaring this as my last Will & Testament & hereby first I give and bequeath my Soul to God Almighty the giver in full & sure hopes of the glorious resurrection thro' the merits of Christ Jesus my only Saviour & his grace and my body to the Earth from whence it came to be decently buried according to the directions of my Ex^o. last after name & I give and bequeath my will is that all my just debts and funeral expenses be first paid out of my personal Estate.

31st I leave to my beloved wife Jane the use of all my Estate during her life
 32nd I give bequeath to my beloved daughter Mary, £100, Ten shillings.
 33rd I give and bequeath to my beloved son John Edwards. Ten shillings
 34th I give and bequeath to my beloved daughter Elizabeth Allen Ten shillings
 35th I give and bequeath to my beloved daughter Jane, Harbison Ten shillings
 36th I give and bequeath to my beloved daughter Hannah Allen Ten shillings
 37th I give and bequeath to my beloved son Phillimon Edwards after my wife's
 decease all my Estate not before given or bequeathed wholly and solely both
 Royal and personal.

38th I appoint my beloved wife Jane Exec^r. with my beloved son Phillimon
 Edwards Exec^r of this my last Will and Testament published May 15th 1765.

 and I the said Henry Tomple the said Negro boy Tom unto the said Samuel
 Tomple his heirs Ex^rs. Adm^rs. & Assigns for ever. Shall & will warrant & for ever
 defend against me my heirs Ex^rs. & Assigns & all other persons whatsoever In Witnes
 whereof I have hereunto set my hand & seal this first day of June 1765
