and the uncertainty of all human affairs do make, publish
and declare this my last will and testament in whole as
follows that is to say,

Item (1) My will and desire is that my executors herein
after named shall sell one of my tracts of land known
as the White Harrison and Coopertown land containing about
Two Hundred Acre to pay the debt & owe Homestead and
Item (2) I will and bequeath that all the remainder of my
Property both real and personal after my just debts are
paid shall go to my wife Mary S. Garrett and my children
Alfred S. Garrett, Remie Garrett, Jessie Harriet and
Margaret Garrett to be held by them equally in the simple
according to valuation my wife Mary S. Garrett to take
that part which includes my dwelling house together with
all the other houses surrounding the same.

Item (3) My will and desire is that my executors shall
pay Carrie Hilliard Ten Dollars and shall pay
Henrietta Stuck Ten Dollars and the said sums shall
be a charge against my estate my reason for giving
Carrie Hilliard and Henrietta Stuck being that of my
deceased Daughter of the same name only Ten Dollars less
is that I have already advanced to them more than I am
able to give each of my other children.

Item (4) I will and devise my graveyard to the
Episcopal Church the same covering one acre of land to
be held in fee simple.

Item (5) I name and appoint my wife Mary S. Garrett
and my son Alfred S. and Remie Garrett my executors
to execute this above will and hereby give them full power
to sell any of my property to pay my debts and the expenses
arising.
