First. I leave and devise unto my beloved wife, Mary E. Reary, all of my real and personal property, of whatsoever, kind and wheresoever the same may be found during her natural life or widowhood.

Second. After the death of my beloved wife, I give and bequeath unto my son, Marcus E. Reary, all of my land on the South side of the back-woods road and running a straight line to Mr. J. R. Phelps' line, thence South by west to his line to Hilliard Besses line, thence along said Hilliard Besses line to Mrs. Anna Lucas' line, thence along his line Northwesterly to the back-woods road.

Third. After the death of my wife as mentioned above, I give and bequeath unto my three daughters, namely, Ella Mary Basnight, Maggie Olive and Miles Christian Reary, all of my land on the North side of the back-woods road and north of the line so mentioned above which includes the place on which I do now live.

Fourth. I hereby revoke and declare utterly void all other wills and testaments by me hitherto made by witness whereof I, the said Enoch H. Reary, do hereunto set my hand and seal, this 19th day of November, 1909.
