Be it remembered that on the 16th day of July, 1868, I Thomas H. Turner of the State and County aforesaid being of sound and disposing mind and memory, do make and contain this my last will and testament in manner and form following that is to say.

Item 1st I leave to my son Sampson R. Turner the land and plantation whereon I live adjoining the lands of Thomas L. Hassell Sarah Gaylord and Thomas J. Waller during his natural life and then I give and bequeath said land and plantation to my Grand son, Thomas H. Turner the son of Sampson R. Turner to him and his heirs and assigns forever.

Item 2^d I give and bequeath to my son Sampson R. Turner all the rest and residue of my estate of every description to him and his heirs and assigns forever the said Sampson R. Turner paying to my daughter Eliza Curtis two hundred dollars on the above bequest to stand void.

I nominate constitute and appoint my son Sampson R. Turner and my son in law Henry Curtis sole executors to this my last will and testament hereby revoking all other and former wills by me at any time herebefore made, in witness whereof I have hereunto set my hand and seal, this the year and day above written.

And these deponents and each of them further say that at the same time when the said testator subscribed his name to the said last will as aforesaid and at the time of the deponents subscribing his name and their names as attesting witnesses thereto as aforesaid the said Thomas H. Turner was of sound mind and memory of full age to execute a will and was not under any restraint to the knowledge information or belief of this deponent or either of them and further these deponents say not.
