3. I give to my friend Anna Skinner my organ.

4. I do hereby give all the rest of my personal property to Hallie Lovelle and Dawson Stewart to be equally divided between them.

5. I do hereby give and devise to my friend Hallie Lovelle my house and lot situated in the town of Plymouth, N.C. subject to the life estate of Dawson Stewart. I reserve from the operation this gift and devise the cemetery on said lot which shall never be sold and the said Dawson Stewart shall always keep in good condition the lots in said cemetery.
