I, M. J. Stillman, being of sound mind, but considering the uncertainty of my earthly existence, do make and declare this to be my last Will and Testament, in manner and form as follows, to-wit:

First: My executor, hereinafter named shall provide for my body a decent burial, and pay all funeral expenses, together with all my just debts, out of the first moneys that may come into his hands out of my estate.

Second: I bequeath to my beloved wife, Amelia T. Stillman, during her natural life or widowhood, all my estate, real, personal and mixed, and at her death to be equally divided between my children, then living, and the children of such as are dead, the children of those who are dead, if any, to receive only so much as would belong to their parent if he or she were living. From this devise is excepted any interest whatever that should go to my son, J. B. Stillman, I having already decided to give him his full share in my estate.

I hereby constitute and appoint my beloved wife, my sole executor, without bond, to execute this my last Will and Testament, declaring utterly void all other wills heretofore made by me. In Witness Whereof, I, the said M. J. Stillman, do hereunto set my hand and affix my seal.
