After paying all my debts and funeral expenses out of the money that I may have on hand at the time of my death, I give to my poster or, Mark Skinner, one hundred (\$100.00) dollars and the balance of the money on hand I desire that same be equally divided among all of my children named in the third item of this my last will and testament.

I name and designate my beloved daughter, Hattie Morgan executive of this my last will and testament without bond.
