North Carolina of ⁽²¹⁾ Joseph Bundy of the County of Province
Wayne County & afore said, being of sound mind & disposing
memory, do make & ordain this my last will & Testament
in manner & form following: 1st —
First I give & bequeath to my son Abraham Bundy Fifty
Acres of land, be the same more or less, that I bought of Thomas
Wilson, to him & his heirs for ever —
Second I give & bequeath unto my son William Bundy one
hundred acres of land lying on Great meason Swamp, the
upper part of the tract of land that I bought of Thomas
Wilson to him & his heirs for ever —
Third I give to my son Mark Bundy the remaining part
of the Tract of land that I bought of Thomas Wilson, to him
and his heirs for ever, but if my said son Mark should
die without leaving any heir I give the said land & plantation
Equally between my two sons Gideon & Josiah Bundy to
them & their heirs for ever — Fourthly It is my will
that my loving wife Jane Bundy have the use of the plantation
that I have given to my son Mark during her life, with all my debts
and at her death I give Equally to my six Children Gideon
Josiah Meriam, Hannah & Mary, all my debts not already
bequeathed to them & their heirs & I have nominated & constituted
appoint my loving wife Decatur, my son William Bundy &
