In the name of God Amen, I Isabel Jernigan of the State of North Carolina in Wayne County, being sick of body and of a sound mind & knowing my manner, make bequest, calling to mind the great frailty of woman's kind, and for the better settling my personal affairs, I make & ordain this my last will and Testament in manner & form following. (1st) I Trust & I recommend my soul into the hands of God who give it, and my body to the ground to be buried in a decent manner at the Resurrection & my Executors nothing doubting but at the General Resurrection I shall receive the same again by the mighty power of God. and Touching my worldly Estate which with it has pleased God to bestow on me with in this life I give & dispose of the same in manner & form following. (That is to say)

First, I give & bequeath to my beloved son & daughter John Wiggs & his wife Alice Wiggs one Shilling & specie. I give & bequeath to my beloved son Joseph Halse & his wife Isabel Hayes one Shilling & specie. Item, I give & bequeath to my beloved son & daughter Etheldred Boyt & his wife Bridgetta Boyt my mare by the name of Pegion, & my saddle & Bridle. Item I give & bequeath to my beloved son & daughter Jesse Watkins and his wife Catherine Watkins one Shilling & specie. and after my death the remainder & residue of all my goods & Chattels except my old wench Daffy, her children and any of my

Children which she will, and none of them shall not face her share with them without she is willing to it, and that she shall not be sold nor divided, and the rest I leave to be equally divided between all my sons & daughters that is to say, John Wiggs & his wife Alice Wiggs. Jesse Halse and his wife Isabel Halse. Etheldred Boyt & his wife Bridgetta Boyt. Jesse Watkins & his wife Catherine Watkins. Item Jesse Hayes & Etheldred Boyt whom I likewise constitute make & ordain my sole Executors of this my last will & Testament. and I do hereby utterly revoke and disannul all & every other former Testament, will, Legacies & bequest. & Executors by me in any way before named, wills & bequeathed ratifying & confirming this and no other to be my last will & Testament, in witness whereof I have here unto set my hand & seal this 9th January Anno. dom 1783

Lying upon Blue Creek joining Robert Simms & Captain Simms lines to him and his heirs, also a negro Girl named Anna, the other 2^d I give to my son Arthur Cook one piece of Land bounded by the school house branch & the mill pond branch joining Isaac Woodard line upon the other side supposed to be one hundred & twenty five Acres to him & his heirs, also one feather bed & furniture his Possessions and a negro Girl named Patsy and her increase.
