

47 Peter Pearson's Will - 127

But Remembered that I Peter Pearson of Worcester County in the State of N. Carolina do think proper to settle my outward affairs by making this my last will and Testament viz: first my will is that all my just debts be lawfully discharged by my Executors hereafter named - First it is my will and Desire that my Loving Wife Anne Pearson have her Natural Lifeline on the Plantation whereon I now Live also one feather Bed & furniture two new two Cows and Calves six Cows and Lambs also one pewter Dish one Basin two plates and one Dogen Spoon three knives and forks and two Mugs and Linen what and one Wooling wheel two parafers and Iron pot one Chest one playing span.

Then Give And Bequeath the Plantation whereon I now live to my son Benjamin Pearson to him and his heirs and assigns for ever.

Then Give And Bequeath all the Remainder of my Estate to be Equally Divided amongst my Children their names as followeth. Nathan Joseph Jesse Sarah Benjamin Mary & Penina, to them and their heirs & assigns for ever Lawfully & Legitimate, constitute and appoint Myson Nathan Pearson and Willis Bryant Executors of this my last will & Testament Discharging and making void all other wills by me made acknowledging this to be my last will and Testament Signed & sealed Published Pronounced and Declared to be my last will and Testament the fifteenth Day of May in the year of our Lord one Thousand seven hundred & eighty seven.
