Know all men by these presents that I David Witherspoon
 of Bath County, North Carolina for and in consideration
 of the sum of one hundred pounds Current money of
 said State to me in hand paid by Charles Gordon just
 have bought sold and delivered & by these presents do
 bargain sell and deliver to said Charles Gordon a Negro
 Girl named Rose about fifteen years old (as she swears)
 and thereof Negroe Ida Maria to be a healthy sound
 Girl clear of Bodily infirmities & do likewise hereby
 warrant and defend the aforesaid Negroe to him the said
 Charles Gordon his heirs &c for ever clear of all Incumbrances
 and Claims of any other person or persons whatsoever
 in Wits & witness of these presents Set my hand and
 Seal this 19th Day of August 1794 David Witherspoon

Eliza Baldwin { Item Bond 2000 November Term 1794

Know all men by these presents that we
 Eliza Baldwin Jesse Robnett & Benjamin Jones Esqrs. as Justs
 of the Peace for Bath County North Carolina do hereby certify
 in the Just and full sum of two hundred pounds due to be
 paid to the said Eliza Baldwin Esqr. Governor and his Assigns
 or assigns to which payment with and truly to be made within
 six months our Hives Executives & Administrators lawfully and
 really finally by these presents sealed with our seals and Dated
 the 7th Day of November Anno Domini 1794

The Condition of the above obligation is such that if the
 above Bonded Eliza Baldwin Administrator of the said
 Ann's Dec'd do make or cause to be made a true and perfect
 inventory of all and singular the goods and Chattels rights and
 Credits of the Decedent which have or shall come into the hands
 knowledge or possession of any other person or persons for
 him and the same so made doth exhibit or cause to be exhib-
 ited into the Secretarys Office and one attested copy thereof
 the County Court where order for Administration is made
 within thirty days after the date of these presents and
 the same goods Chattels and Credits and all other goods
 Chattels and Credits of the Decedent at the time of Death
 which at any time hereafter shall come into the hands
 or possession of the said Eliza Baldwin or into the hands or
 possession of any other person or persons for him do well and
 truly administer according to law and further do make or
 cause to be made a true and just account of his said Admin-
 istration within one year after the Date of these presents and
 all the Rest and Residue of the said goods and Chattels and Credits
 which shall be found remaining on the said Administration account
 the same being first examined and allowed by the Governor or his
 General or County Court shall deliver or pay to each person
 or persons respectively as the same shall be due pursuant to the be-
 neficial and meaning of Act in that behalf made and provided and if it
 shall appear that any will or truly money was made by the Decedent
 and the Executor or Executors therein named do exhibit the same into
 the said Eliza Baldwin's Store Bonds or being thereunto required do
 such testimony being first had and made in said Court then the
 full force and Virtue
