The Condition of this Obligation is Such that if the Above Bounden Francis & Edwinston Shill Administrators of all and singular the Goods and Chattels Rights and Credits of James Shill deceased Doe make or Cause to be made a True and perfect Inventory of all And singular the Good and Chattels Rights and Credits of the Deceased Which have or Shall Come ^{into} Hands Knowledge or Possession of them Francis Shill and Edwinston Shill or into the hands of any Person or Persons for them and the same so made doe Exhibit or Cause to be Exhibited into the Secretarys office and One Attent Copy thereof to the County Court where Order of Administration passed within ninety Days After the Date of those presents and thereunto good Chattels and Credits ^{with} all Other the goods Chattels and Credits of the Deceased at the time of his Death which along Time hereafter shall come into the Hands or Possession of Francis Shill Edwinston Shill or into the Hands or Possession of any other person or persons In them dwell and truly administer according to law and further do Cause to be made a true and just account of their said Administration within one year after the date of those presents and all the Rest and Residue of their Goods Chattels and Credits which shall Be paid Remaining upon the said Administration Account the same being first Examined and Allowed by the Governor and Council General Court or Court of County Court shall Deliver and pay unto such person or persons Respectively as they Same shall Be Due pursuant to the true Intent and meaning of the said In that Case made and provided and if it shall appear that any will or Testament was made by the Deceased and Executor or Executors therein named exhibit the same in to Court making Request to have it allowed and approved according to the said Francis and Edwinston Shill above bound being thereunto Required Do Render and Deliver the said Letters of Administration upon presentation of such Testament being first hadon made in the said Court then this Obligation to be void If none of parts or either to Remain in full force and Virtue Signed sealed and Delivered in presence of
