

Benjamin Sparks Will

North Carolina - Yadkin County

I, Benjamin Sparks, Senior, of the County and State aforesaid being of sound mind but considering the uncertainty of my earthly existence, do make and declare this my last will and testament:

First - My executor hereinafter named shall give my body a decent burial, suitable to the wishes of my friends and relatives, and pay all my just debts, out of the first money which may come into his hands belonging to my estate.

Second - I give and devise to my wife, M. J. Sparks and her heirs in fee simple, the following tracts of land to wit: A tract of land situate in New Castle township, Wilkes County, N.C., known as the Mill tract, adjoining the lands of A. S. Hendrix, J. C. Greenwood and others, containing 579 (Five hundred and seventy nine) acres more or less. Also a tract of land situate in Husk's township - Yadkin County, N.C., adjoining the lands of R. W. Swain, George Brown and others, containing 417 (Four hundred and seventeen) acres more or less, being known as the Home place on which I now reside. Also a one half acre lot of land, situate in Jonesville, N.C., adjoining the lands of Mrs. E. A. Becham and others. Also a tract of land in New Castle township, Wilkes County, adjoining lands of Thomas Johnson and the widow Godfrey and others, containing two acres more or less.

Third - I give and bequeath to my wife, M. J. Sparks all of my personal property of whatever kind and nature including moneys, stock and all other personal property.

Fourth - I hereby constitute and appoint my trustee friend, Thomas Armstrong my lawful executor to all intents and purposes, to execute this my last will and testament according to the true intent and meaning of the same, and every part and clause thereof, hereby revoking and disclaiming all, void all other wills

and testaments by me heretofore made.

David W. Norman's Will

I, David W. Norman of the County of Yadkin am estate of North Carolina being of sound mind and memory, but considering the uncertainty of my earthly existence do make and declare this my last will and testament in manner and form following, that is to say. First - That my executor shall provide for my body a decent burial, suitable to the wishes of my relatives and friends, and pay all expenses that occur together with my just debts to whomsoever owing.

Secondly - I give to Lousina Davis, widow of James Davis deed, the ten acre lot of land on which she now lives, together with the privilege of getting her fire wood & using water from the spring of my adjoining land with the right of way to the same, during her natural life time, after which I give it to my Nephew S. E. Norman, who is now taking care of me in my affliction.

Thirdly - I give and bequeath to my Nephew S. E. Norman all of my real estate, the following described tracts of land. Lot No. 1, being the remainder of the 39 acre tract known as the Phisa Mackie lands & lying west of the 25 acres deeded to S. E. - Norman. For further description see the deed from Phisa Mackie & children. Lot No. 2, known as the Perry Strictland lot. For further description see deed from said Strictland, containing two acres.

Lot No. 3, known as the John McCollum tract, containing three acres, situated on the west side of said McCollum's tract. For further description see deed from said John McCollum to David W. Norman. Lot No. 4, known as the Jot Carter lot, containing two acres, adjoining the lands of David W. Norman, Joes Carter lying in an oblong square 140 yards by 70 yds. for further description see deed from Jot Carter to David W. Norman.

Lot No. 5, known as the A. R. Poindexter tract, containing eight acres more or less, adjoining the land of John McCollum & others & situated on the road leading by Union Grove to East Bend for further description see deed from A. R. Poindexter to David W. Norman.
