Item 1st I will and desire that My Executor herein after named
 pay and fully discharge all my just debts, to whomsoever

 Item 2nd

I will bequeath, and assign unto my beloved wife of this
 the Tract of Land where on I now reside, containing One
 hundred and Sixty Eight acres; also an other Tract
 adjoining the above tract and known as the Calloway
 tract, containing one hundred & fifty acres, to have & hold
 pass on and enjoy the above tracts of Land with every
 appurtenance thereto belonging, during her natural life
 Solo, give unto & bequeath to my wife, all my Stock of
 Hogs, Cattle, Sheep, & farming tools, Wagons, Horses, &
 other kitchen furniture, and every species of personal
 property, except money, notes & such her natural life; and at
 her death all the above species property remaining, I give
 & bequeath to my Son W. S. Roberts.

Item 3rd I will, assign, give bequeath and convey unto my son
 T. S. Roberts the tract of Land where on I now reside, containing one
 hundred & Sixty Eight acres more or less; also an other Tract con-
 taining One hundred and fifty acres more or less adjoining
 the above tract, and known as the Calloway tract, with every
 appurtenance thereto belonging which tract will come into
 his possession, at the death of my wife and to his heirs
 and assigns forever in fee simple.
