their single life, as they now live (viz)
Minny & Sally to live with my wife Cecilia and
Barbara Misher to live in the house she now
lives in.

I also give to my three daughters above
named all the land and other property
at the death of my wife to hold and occupy
during the time that they may remain single
and wish to hold in possession the above
named ~~land~~ and property. I also give and
bequeath to my said daughter Rebecca Asher
Acres of land as surveyed bounded as follows

Beginning at a black oak stump on the south
side of the Georgia road runs south nine
chains to a post oak in the Fair County
line, ^{thence west with the boundary} then
runs ~~then~~ chains & 25 links to a pine then
with thirty four chains to a black oak thence
east eighteen chains to a post oak thence
south to the Georgia Road to a post oak thence
with the road west to the beginning con-
taining fifty acres.

I also give to my youngest son and to his
heirs Asher Asher the place where he
now lives as long as he may stay on it and
