being sick in body but of sound mind and memory
and understanding Considering the certainty
of Death and the uncertainty of the time thereof, to see
that I may be the better prepared to leave thence
when it shall please my God to call me hence have
now determined to direct what disposition shall be
made of my property after my decease, and after
maturely considering the circumstances and condition
of all those among whom as my heirs at law or the
objects of my gratitudo affection in my judgment
my estate shall be distributed, I do make publish
and declare this to be my last will and testament
hereby revoking making null and void all previous
last wills and testaments by me heretofore made
and my will is 1st that after my decease any
body shall be decently buried without unnecessary
expences, and that my personal charges and just
debts shall be paid by my executor and as to the
residue of my estate and property with which
God has blessed me and shall not be required
for the payment of my debts funeral charges and
expences in and about the execution of this my
will and the administration of my estate I give
desire and despose thereof as follows to wit;
2nd I give and desire to my beloved son Emry S.
Angle all of my personal property to wit;
one Bureau or Clock case table four beds and fur-
niture, one Cook Stove and fixtures one safe one table
and all the table ware, one one Horse wagon one black
mare mule together with all personal property
water credits and moneys that I may be in possession
of at my death to have and to hold the same to him
and to his executors and administrators and assign
to his and their use forever Provided that the said
Emry S. Angle shall take care of me and provide
for me during my life time, and I do nominate

and appoint my trust worthy friend F. Mackay to see
the sole executor of this my last will and testament.
