

# UNION COUNTY SC DEED ABSTRACTS

District in the angle of Broad and Tyger River, 500 acres. 12 Nov 1821. William Smith (LS). Wit: J. N. White, Wm. W. Glenn. Mrs. Margaret Smith, wife of William Smith, relinquished dower in York District 29 Oct 1823 before J. N. Whyte, Q.U. Proved in Union District by the oath of William W. Glenn 3 March 1824 before James Meng, Q.U. Recorded 3 March 1824.

**R, 420:** South Carolina, Spartanburgh District. Whereas William Thomson deceased has by his will devised to myself during my life all his negroes and their increase except four, two of whom are willed to Mrs. Collins and two to Mrs. Mackey his daughters, and directing that each of his grand children to wit Sarah Moore wife of Gorden Moore, Narcessa Otterson wife of Doctr. Saml Otterson, Nancy Macke, Melisse Norris wife of William Norris, William Nuckles, Wm. H. Thompson, Joseph W. Thompson, Barlow T. Collins and Caroline Collins, should equally divided among them the said negroes at my death, and whereas I am desirous that the said children should immediately enjoy the said estate, now I, Richard Thompson, for \$1 paid by children, have sold the seven fifteenth of said negroes so willed to me by my said father, 3 Feb 1824. Richard Thomson (Seal), Wit: Thomas Williams Junr. Recorded 5 March 1824.

**R, 421:** South Carolina, Spartanburgh District. Whereas Richard Thomson has this day assigned over to us the seven fifteenth of the negroes willed to him by his father William Thomson, deceased, now we Gorden Moore and Sarah his wife, Doctr. Saml Otterson and Narcissi his wife, Nancy McKie, William Norris and Melissi his wife, William T. Nuckles, for ourselves & Joseph Collins for and on behalf of Barlow T. Collins and Caroline Collins his infant children, do sell to Richard Thomson the one eight part of the said seven fifteenths of said seven negroes, 3 Feb 1824. Gorden Moore (Seal), Sally Moore (Seal), Saml Otterson (Seal) and Narcissa Otterson (Seal), Nancy McKie (Seal), William Norris (Seal), and Melisa Norris (Seal), W. T. Nuckles (Seal), Jos Collins (Seal) for Thomas P. Collins & Caroline Collins (Seal), Wit: Samuel O. Lay, Elizabeth Luck, G. T. Rochell, Thos Williams Junr. Recorded 5 March 1824.

**R, 421-422:** John Bates, Sheriff of Union District, by virtue of writs of fieri facias from the court of common pleas for Union District tested the first Monday in March 1823 at the suit of Simson Foster Indorsee vs James Martin & Jeffrey Palmer and at the suit of James F. Walker against James Martin to levy of the goods and chattles, lands and tenements of James Martin \$200, sell tract of 200 acres adj. lands of Polly Wilbourn widow, Hannah Brooks, Nathan Harland, and Thomas Craven on Salley Branch, waters of Fairforest, purchased by Gist & Coleman for \$284, 2 March 1824. John Bates S. U. D. (LS), Wit: Danl A. Mitchell, E. M. Bobo. Proved by the oath of Daniel A. Mitchell 6 March 1824 before Jeffrey Palmer, J.P. Recorded 6 March 1824.

**R, 422-423:** So Carolina, Union District. Gist & Coleman of district aforesaid for \$288 to Daniel Palmer of same, 200 acres on Salleys branch, waters of Fair Forrest adj. Polly Wilbourn, Nathan Harlan, Hannah Brooks, Thomas Craven,

**R, 423:** South Carolina, Union District. James Martin of district aforesaid for \$500 to Jeffrey Palmer of same, one negro girl named Jane and one dark bay horse, one sorrel mare, two cows and fourteen head of hods and 30 barrels of corn, and three feather beds, one cupboard and all my plantation tools, one shot gun, one rifle gun, 3 March 1824. James Martin (Seal), Wit: William Smith, Wade Woodson. Proved by the oath of William Smith 6 March 1824 before Lem B. Askew, J.Q. Recorded 6 March 1824.

**R, 423-424:** Jacob Crocker of Union District for \$900 to Samuel Otterson of same, plantation where said Jacob Crocker lives near William Colter's[?] store, 246 acres, 16 Jan 1824, Jacob Crocker (LS), Wit: S. J. Hoey, J. L. Reid. Proved by the oath of Saml J. Hoey 16 Jan 1824 before S. Jeffries, J.P. Recorded 5 Feb 1824.

**R, 424-426:** South Carolina, Union District. 25 Jan 1824, William Hasell Gibbs Esqr., Master of the Court of Equity for the Southern Circuit at Charleston, to David Myers of Kershaw District, Esq., whereas Andrew Hasell, Bentley Hasell and Joanna Hasell, minor children of Dr. Geo. P. B. Hasell, late of Charleston, decd, by their next friend Dr. Paul Weston on or about 15 March 1821 did exhibit their Bill of Complaint in the Court of Equity at Charleston against Andrew Hasell, wherein they stated that the estate of their deceased father at the time of his death was much incumbered by debts which the creditors who had been very indulgent were pressing for and insisted on payment thereof, that the estate had no means of discharging the same from the income thereof or from the proceeds of the crops arising from the labour of the negroes employed on the plantation, which were little more than sufficient to meet their expences of clothing & the support of the minors with the taxes and other incidental expenses, and that the lands were not productive being at a considerable distance from Charleston the residence of the said Dr. Paul Weston who managed the same, prayed the court to direct a sale of the said lands and negroes... heard at March Term 1821, and the court did decree that the said tract should be sold, now sold for \$11,400 to David Myers, esqr., said plantation on the south side of Tyger River containing about 820 acres purchased from Benjamin Haile by said Dr. Hasell adj. lands of Stacey Cooper, Charles Spiva, John Kennedy & Pruitt, William Rogers, also two other tracts on the west side of Tyger River on Black Rock, about 241 acres, 100 acres of which was granted to Jesse Young in 1772, the remainder also to him in 1785, also two tracts of land in Berkley County each of 100 acres between Broad & Saluda Rivers laid out to Robert Kennedy and the other to John Kennedy bought from them by Samuel Kennedy & conveyed to said Geo. P. B. Hasell. Wm Hasell Gibbs, Master in Equity (LS), Wit: Edward Gibbs, Allston Gibbs. Proved by the oath of Edwin Gibbs in Charleston District 2 April 1824 before Peter G. Parker, N. P. & Q.U. Recorded 19 May 1824.
