Bird of Edgefield County

The Birds descend from **Edward Bird**, born ca 1640, died 1697 in Accomack County, Virginia¹ who probably married Jane Spiers, the daughter of John Spiers.² John Bird was named as a friend "my wife's brother" in the LWT of Richard Lincoln, dated 3 Jan 1615/16, probated 24 Feb 1620 at Norwich, England.³ "To Sarah, wife of Henry Bird. My wife's brothers: Edward and Henry Bird". Known issue:

- John Bird who died 1727/8 in Accomack County, Virginia. 4
- Daughter who married William Rodgers (Rodgers died 1738 in Accomack County, inventory of his estate)

John Bird had issue:

- 1. Nathaniel Bird, died 1780 in Accomack County, Virginia. Wife, Margaret. In his LWT he named his brother, Solomon.⁵
- 2. Solomon Bird, born ca 1700, died 1784.⁶ He was married to Frances Bull, a granddaughter of Tobias Bull who named her.⁷ Known issue:
 - a. Esther Bird.
 - b. Rebecca Bird.
 - c. Scarbrough Bird.
- 3. Major Bird, born ca 1710 (under age 18 at the time of his father's death).
- 4. Eborn Bird.
- 5. Daniel Bird, born ca 1720, died 1751 in Accomack County, Virginia. Wife, Margaret.⁸ "That the said George Philby being so in possession by deed dated 7 March 1737, conveyed the premises to Daniel Byrd, and that Daniel Byrd by virtue of said deed

entered into the promises and was thereof possessed, and by his deed dated 6 March 1739 conveyed the same to George Philby the younger..."9

- f. Elizabeth Bird married Benjamin Parks.
- g. Daniel Bird, served in the South Carolina Militia during the Revolutionary War; sometimes furnishing supplies.¹¹

Solomon Bird (ca 1755-1810) was listed on the 1800 Edgefield County Census. His LWT named his daughter, Rachel Jourdan and the other children. Wife, Nancy. Issue:

- Rachel Bird, born ca 1790 in Edgefield County, South Carolina, married ca 1810 Jesse Jordan of Edgefield County; they removed to Georgia; died in DeKalb County, Georgia
- ii. Esther Bird, married Mr. Smith.
- iii. Mary Bird, unmarried.
- iv. Elijah Bird.
- v. Ebone Bird, born 1795.
- vi. John Bird.
- vii. Billons Bird, born 1797, died before 1850 in DeKalb County, Georgia. He was married to Charity Tyner on 2/15/1815 in Elbert County, Georgia.
