

Perryman of Virginia & South Carolina

Richard Perryman, the son of Richard Perryman and his wife, Mary (Lovell) Perryman, was born 1709 in Skimona Creek, York County, Virginia and died 1765. Wife, Mary. Issue.

- William Perryman, born ca 1715 in York County, Virginia.
- Robert Perryman, born ca 1728 in Halifax County, Virginia, died 1813 in Putnam County, Georgia.
- David Perryman, born ca 1729 in Halifax County, Virginia, died 9/24/1804 in Columbia County, Georgia.
- Richard Perryman, born ca 1730 in Halifax County, Virginia, died 1784 in Burke County, Georgia. He was married to Martha DeJarnette, a daughter of Daniel DeJarnette and his wife Martha (Ford) DeJarnette. Issue.

1. Benoni Perryman, born ca 1759, died 7/1826 in Mary Co., Tennessee.
2. Daniel Perryman, born ca 1760.
3. Mumford Perryman, born 1762 in Prince Edward County, Virginia, died 1820 in Edgefield Co., South Carolina. He was married to Elizabeth, a daughter of Barrick and Ann Travis. Mumford was in Edgefield County prior to 1805 as evidenced by a deed from John Bland to Mumford Perryman of Edgefield County dated 1/3/1805 for \$54.00, 25 acres of land situated on Cedar Branch of Mine Creek of the Little Saluda River, it being part of 200 acres granted to Charles Greville Montgue in May of 1772 to Arthur Fort, bounded on Mumford Perryman's line. The Last Will and Testament of Mumford Perryman was dated 9/5/1820, probated 10/12/1820 in Edgefield County wherein he named his wife, Elizabeth, and a son, Barnett Perryman.

- i. Milton Travis Perryman, born 9/28/1794 in Edgefield County, died 9/26/1871 in Mobile, Alabama, buried in the Magnolia Cemetery.
- ii. Samuel Perryman, born 2/17/1797 in Edgefield Co., died 6/17/1838. The Last Will and Testament of Dr. Samuel Perryman dated 5/7/1838, probated 8/17/1838, named his wife, Sarah A. and his children. They were residents of Abbeville Co.,

South Carolina. At his death he directed that a plantation located in Lowndes County, Alabama which he owned with Dr. J. P. Barratt, be sold and the proceeds divided between his wife and children. "The amount owed me by Jas. Hagood of Lowndes County, Alabama, formerly of Edgefield District, South Carolina, to be given back to said Hagood." He also named his brothers and sisters, viz: Alexander, Milton T., Martha Gallagher and Nancy Medlock. Edna Caldwell, guardian of Ann Caldwell, was paid \$1,139.52 and H. H. Creswell and his wife received part of the settlement. Issue: William Perryman; Samuel Perryman; and Richard Mumford Perryman.

- iii. Barrick (or Barnett) Smallwood Perryman, born ca 1799 in Edgefield County, died 1838 in Abbeville Co., South Carolina.
 - iv. Alexander Perryman, born ca 1801 in Edgefield Co.
 - v. Nancy Perryman, born ca 1803 in Edgefield Co., married Mr. Metlock.
 - vi. Martha Perryman, born ca 1805 in Edgefield Co., married Mr. Gallagher.
