Francis White being indisposed in Body but Sound in Memory & mind I do make this my last will & Testament of my body Revoking & Disannulling all others by me made I give & dispose of my worldly property as follows I give unto my Son Francis White one Negro Boye by the name of Joshua & thirty the Dollars to be appropriated for his Schooling I give unto my Grandson Francis White Bastick, one Negro Boy, Burgess whenever he arrives at Twenty One years of Age & the profits of this boy to be appropriated by executors in the most advisable manner in order to support this above name Grandson and in Case either my son or my above name Grandson dies under the Age of Twenty One years without lawfull Issue of there Body that the said Negroe or Negroes to revert to my Estate and be divided amongst my Legal Representatives Likewise I give & Dispose of all my Negroes except the two boys all ready disposed of to my above named Children as follows, Robert White, William White, Durrett White Frances White, Elizabeth Edwards, Cath. White Judea Edens to be equally Divided amongst them also all the Household furniture & Chiten also all the Plantation Utensils: Stock of Horses Cattle, hogs, Sheep & the Crop and all the Land that I possessed also my desire is that my Son Robert White & Thomas Edwards be Exrs of this my last will & Testament Given from under my hand & Seale this above day & Date Signed & Acknowledged in the presence of Our Subscribing Witnesses- John Conner- John Shotwell- James Edens)
