But of perfect mind and Memory thanks be give unto god. calling unto mind the Mortality of my body and knowing that it is appointed for all men once to die do make and ordain this my last Will and Testament, that is to say principally and first of all. I give and recommend my Soul into the hands of almighty God. that gave it and my body + recommend to the earth. to be buried in decent christian burial at the discretion of my Executor. nothing doubting but at the general resurrection I shall receive the Same again by the Mighty power of God. and as to touch my worldly Estate wherewith it has pleased God to bless me in this life. I give demise and dispose of the Same in the following manner and form. First I give and bequeath unto My Three Sons namely . John Wiley and Allen Glover the sum of five shillings sterling money each--- Secondly. I give and bequeath unto my Daughter Willey Harris the sum of five shillings sterling money--- thirdly. I give and bequeath unto my Son Benjamin Glover Whom I likewise constitute make and ordain the Sole Executor of this my last will and Testament- One negro boy about nineteen years old named Moses Fourthly . I give and bequeath unto my Grand Daughter Caroline Young One ~~negro~~ Woman about Sixteen years old named Lotty. But if my Grand Daughter Caroline Young should die before she arrives to lawful age than in that case . I give and bequeath unto my Son Benjamin Glover the aforesaid negro woman named Lotty with her future increase and Issue. fifthly my will and desire is that my Executor do set up at Public Sale . on a twelve months Credit the purchases giving approved by the County with

I give and bequeath unto my Son Benjamin Glover the aforesaid negro woman named Lotty with her future increase and Issue. fifthly my will and desire is that my Executor do set up at Public Sale .on a twelve months Credit the purchases giving approved Security. the following property-- My Negro fellow Jack . all my lands Stock of every kind poovisions. Houshold and and kitchen Furniture- and all the money that arrises from the Sale with all lawful debts due to me, after discharging & paying all my just debts. I give and bequeath to my son Benjamin Glover. But when my Grand Daughter Caroline Young Should arrive to lawful age. than

in that case my will and desire is that my son Benjamin Glover whom I have appointed my Executor after paying my Just debts as afore said do pay unto my said Grand Daughter Caroline Young one half of such money in his hands as is made out of my estate Sixtly my Negro Woman Sarah I sett free. under the descretion of my son Benjamin Glover whom I do appoint as Trustee over and for her my said Negro Woman Sarah . and lastly my will and desire is that my Executors Benjamin Glover do take unto Possession My Grand Daughter Caroline Young with her negro Lotty as aforesaid & to bring up my Grand Daughter Caroline Young and give her necessary Cloathing and Schooling. I do hereby utterly disallow and revoke all and every other former Testament and Wills rattifying & Confirming this My last will and Testament- In witness whereof I have hereunto set my hand and seal this thirty first day of December one thousand seven hundred and Ninety Six----
