August in the year AD 1794, make and publish this my last will
and Testament in manner following (that is to say, in premis
I Give to my Beloved Wife Jeppet, the use of one tract of Land kn
known by the name of Champbells Spring Tract During her natural
Life Containing as is Supposed Eighty Acres be the same Less or
more, also the Half of my Stock of near Cattle, also the Half
of my plantation Tooloo. During her life and at her Death my
will is that the Land and all the forementioned articles of
Every Kind Shall be Given to my Son Hugh Calhoun my will
further is that after my Just Debts funeral Expenses and here-
after named Legacyes be paid, the Residue of my Estate. - Real
and personal be Vested and freely Given to my Son Hugh Calhoun
his heirs and assigns forever my Will further is that my
Executors pay if Demanded Unto my Son Ezekil Calhoun and my
Daughter Mary Morrow five Shillings each and I make Constitute
and Ordain my freinds M^r James Noble Fleming Bates and my Son
Hugh Calhoun my Executors to this my last will and testaments
