First it is my will and desire that my body be decently buried at the discretion of my herein after named Executors---

Item I will and desire that all my just debts be punctually paid out of such money as may now be due to me as soon as the same can be collected after my decease--

Item I give and bequeath to my loving and faithful wife Jennet during her natural life all my Estate real and personal to her use and benifit

Item After the death of my wife it is my will & desire that my negro wench Sean and her two Children Derry & Charlotte should be free and I do hereby after the death of my said wife manumit and set free the aforesaid three negroes and their then future increase forever.

Item It is further my will and desire that after the death of my aforesaid wife all my estate real and personall shall be sold by my herein after named Executors to the survivors or survivors of them and the proceeds of such sale to be divided into two equal parts one part or half of which said proceeds I will and desire to be paid in such manner and to such persons as my wife Jennet shall by her last will and Testament appoint and direct and I do hereby give unto my said wife full power & authority by her last will and testament to dispose www.southcarolinapioneers.net

Item I do hereby constitute my trusty friends John Bowie srne James Cardlaw George Bowie and Andrew Bowie Executors of this my last will & Testament--

And I do hereby revoke and forever disallow all and every other will & Testament by me heretofore made-- and I do hereby publish pronounce and declare this to be my last will and Testament, given under my hand and seal this thirteenth day of November one thousand and eight hundred and two
