In the Name of God Amen I Isaac Mitchel of the State of South Carolina & County of A bbeville being not in perfect health of Body but of perfect mindand Memory & Calling to mind the Mortality of My body & knowing there is a time for all men Once to die do Make Ordain & Constitute this my last Will & Testament that is to say first I recommend my Soul to God that gave it & my body to the earth to be Buried at the Discretion of my Executors hereafter Named and as Touching such "orldlyEstate wherewith it hath pleased God to blefs me with I do Give & Expose of it in Manner & form following(viz) After discharging all Just Debts I leave the plantation whereion I now live with Three hundred Acres of land begining at the lower line & runing it off in a Square to my Son Isaac my wife to have her life on the plantation. The rest of my Lands to be equally Divided amongall my Other Sons(Exceptine the land on the east Side ofCharles Allens Spring branch including the Spring which I have to the Said Allen as far as my right will allow & whereas I have Given to my Daughters that is Married (towite) Unto my Daughter Ursula One Negro wench, unto my Daughter Cathorine One wench & child unto my Daughter Mary one Wench & unto My Daughter Sarah One Wench which is my will they should keep, & unto the rest of my Children I leave One Negro each, & the remaindor of my Negroes I lend unto my Wife during her life or widowhood & at her Decease or intermarriage to be equally Divided among all my Children-- The rest of my Estate I lend Unto my Wife during her life or Widowhood and after her Decease or intermarriage to be Divided among all my Children, Agter Deducting the Valur of what each married Child hasreceived Excepting the Negroes. And lastly I do hereby Ordain and Constitute my loving Wife Marymy Executrix & my friend Nathan Sims, Robert Pollard, Richard Pollard & my son Isaac when he comes of age my Executor
