WILLIAM CLARK

In The Name of God Amen I William Clark of the State of South Carolina wheel right Being very sick and weak but in perfect mind and Memory thanks be given unto God--Ca lling to mind the Mortallity of mybody a nd Knowing that it is appointed for all men once to die Do make and ordain this my Last will and Testament that is to say principally and first of a ll I give and Recommend my soul into the hand of A mighty God that give it and my body I Recommend to the Earth to be buried in Decent Christain burial at the Discretion of my Executors nothing Doubting but at the general Resurrection I shall Receive the same again by the mighty power of God, and as touching my worldly Estate wher with it has pleased God to Bless me in this life, I give Devise and Dispose of in the folling Manner-- First and first I give and Beq ueath to Mary my Dearly Beloved wife all that plantation or track of land which I now live on Containing one hundred Acres as also my Negroes named as followeth viz. Judy Plinda June peet Ben and Milley as also my live live Stock of ~~Went~~ Cattle horses hogs and sheep also my house hold furniture Plantation tools During her natural life or pleasure also to my son David /I will and Bequeath my negroe Boy named peet and also to my son Alexander all that plantation or track of land Containing one hundred and fifty Acres known by the name of puttees, and also I will and beq ueath to my Daughter Jane My negroe wench named finda and the heirs of his Body and if my daughter dies without an heir the wench to return to my Estate and also I will and bequeath to my Daughters Mary my Negroe wench named Jude a nd my Negroe Boy named Ben and to the heirs of her Body and if shew dies without an heir the Negroes to return to My Estate, and Also I will and beq ueath to my Daughter Susana My Negro wench named milley and if my Daughter dies without an heir of her Body the wench to faul to my Estate Again, and also I will and bequeath to my sun Robert and William all that plantation or tract of land containing one hundred Acres known by the name of Benifields survey and all that tract of land that I surveyed last to be Equally Divided between from the river out and also I will and bequeath to my son John Gluston my Negroe boy named June, ~~Ben~~

their legases at the Death of My wife Mary Clark, I do hereby
make ordain Constitute and apoint my dearly Beloved wife Mary
Clark and my son Alexander Clark the hole and sole Executors
and Executors of this my last will and testament and I do hereby
utterly disallow revoke and disannul all and Every other former
testaments wills Legases Bequeaths and Executors By me in any
ways named and named willed and bequeathed Ratifying and con-
firming this and no other to Be my last will and testaments in
witness whereof I have here unto set my hand and seal this third
day of July 1790
