First I give and bequeath unto my beloved wife Suffy the plantation and tract of land whereon I now live containing one hundred acres together with all of the household and kitchen furniture on my premises at my disease and such plantation tools as may be needful for her use, and benefit during her natural life -- I have given to Peggy Dorcas and Catharine and to James and Samuel each what stock and household furniture I tend for them to have and the remaining portion of my household stuff and stock to be equally devided between my other three children (viz) Ephraim Kilsey C. and Sally-- To my son Janus I give a portion of this tract of Land whereon I live--following the direction of the Spring branch from Todds line to Browns Road thence to bro.
