To all whom it may concern-I John Corr Sen of the State and District aforesaid being of Sound mind but weak in body Knowing that is appointed unto all men to die and viewing my end as not far distant-Do make and constitute this my last will and testament -- --

- 1. I will and desire that after my decease my mortal remains be decently buried; the expences to be paid as hereinafter mentioned -- --
- 2. I will and bequeath all that tract of Land on which I now reside, together with my three negroes named Baalam--Chane-- and Lewis to my beloved wife Polly Corr to be held and enjoyed by her during the term of her natural life and at her death to be sold and the proceeds arising therefrom to be equally divided between all my children or their heirs --.
- 3. I will and bequeath all my Household and Kitchen furniture to my beloved wife Polly Corr to be at her disposal during her life and subject to her will at her death.
- 4. It is my Will and desire that all my Stock- consisting of Horses -- Cows -- Sheep and Hogs be sold as soon after my death as shall be convenient -- the money arising therefrom to be applied in the following manner. First, my debts and Funeral expenses to be paid out of it. Secondly--the Balance to be equally divided between my wife Polly Corr and my children.
- 5. In the last place I hereby appoint my beloved wife Polly Corr and my beloved Sons John Corr Jun and Laban Corr to be my Executors to this my last will and testament, with full power
