Anderson District) being of Sound mind but weak in body and
knowing It is appointed for all men to die do make and ordain
this my last will & testament --

I allow My wife Lunah to keep pofsesion of the house and
place whareon I now live togather with the use of all the negros
Except two Boys Harry & frank - togather with all her beads &
furniture and all the kitchen furniture also all my Stock of
Cattle to be and remain in her posesion so long as She may live
and at her death the above property to be divided if the Same
Can be don without Sale, if not to be Sold and divid as below

I give and allow unto My Daughter Margeret Cornelious an
Equel Share of the above propirty Except the two boys Harry &
Frank after the S^d Margeret Reducts the amount of two hundred
Dollers which I ha~~ve~~^d her in the price of a Negro girl Selah

I give and allow unto My Son Adam an Equil Share of my
personal property Except as above Harry & frank after deducting
from Adams part the amount of One hundred & twenty Dollers part
of which I paid John Turner & Christopher Hargrove & James Hart
for My Son --

I give and allow unto My Daughter Janny Holly an Equel
part of my personal property Except the two boys above named
after deducting from her part the amount of two hundred Dollers
which I have paid her in the price of a Negro Girle Liza

I give and allow unto My Son Amos an Equel Share of my
personal property Except the two Boys within named after the
Said Amos deducting from his part or paying the amount of two
Hundred & thirty Dollers which I paid for him to Ferabee Cox-for

Cattle to be and remain in her posesion so long as She may live
and at her death the above property to be divided if the Same
Can be don without Sale, if not to be Sold and divid as below

I give and allow unto My Daughter Margeret Cornelious an
Equel Share of the above propirty Except the two boys Harry &
Frank after the S^d Margeret Reducts the amount of two hundred

I give and allow unto My Son Adam an Equil Share of my
personal property Except as above Harry & frank after deducting

part of my personal property Except the two boys above named
after deducting from her part the amount of two hundred Dollers

I give and allow unto My Son Amos an Equel Share of my
personal property Except the two Boys within named after the
Said Amos deducting from his part or paying the amount of two
Hundred & thirty Dollers which I paid for him to Ferabee Cox-for
him --

~~I give and allow unto My Son John the plantation & tract~~
of Land whareon he now live which has been disignated to him
in the presance of Matthew Clark James Rosamond & Thome Thomas
amounting to Somthing like Seventy -- Acres he the Same more or
lefs for Ever -- also give him an Equel Share of my personal
property Except the two boys above named and after deducting
from his part of the Estate one hundred & nineteen Dollers

which money I paid for him to James wood John Gentry & Henry Cox.

I give and allow unto My Son W^m the plantation and tract of Land whareon he now live which lines has been Disignated in in the presants of Mathew Clark--James Rosamond & Tho^s Thomas Containing Seventy five acres be the same mor Lefs for Ever-- also an Equel Share of My personal property with the Exception of the two boys Harry & Frank--above named --

I give and allow to my Son James the plantation & tract of Land whareon he Now Livs which lines has been Difsegnated in the presance of Mathew Clark--James Rosemond & Th^s Thomas Containing about Seventy five acres be the Same more or lefs also an Equel Share of my personal property with the Exception of the two boys Harry & Frank- above named .

I give and allow unto My Son David J. the plantation & tract of land wharon I now live which lines has he Difsignated in the presanc of Mathew Clark James Rosemond & Th^s Thomas at the death of my wife also the two boiys above named Harry & Frank also an Equel Share of My personal property after all My Just debts are paid and any Expences that may occur on my Death or burial--and for Cary my will Into Effect I do nomamate & appoint James Morrys & David J. Morrys My two Sones My Executors of My last will revoking all others in witnefs whereof I have herunto Set my hand & seal in the prenc of Aprile 27th 1830
