Anderson District --

I John Warnock, of the State and District aforesaid for the disposition of such property as it has pleased God to blefs me with do make and ordain this my last Will and Testament--

First-- I give and bequeath to my beloved wife Ellenor Warnock during her natural life all my Estate both real and personal after the payment of my just debts except so much as is herein specifically disposed of. Though it is declared to be my wish and desire that any perishable or other property which will better contribute to the comfort of my said Wife by being used or disposed of shall in her discretion be subject to such controul and disposition and after the death of my wife the said remaining property shall be equally divided amongst all my children or their legal representatives share and share alike without any regard to the bequests herein made or advances heretofore made to any --

Second -- I give and bequeath to my daughter Jane a negro girl Lucy and her future increase during the natural life of my said daughter and after her death to the heirs of her body or dying without issue to revert to my Estate and be equally divided between my lawful heirs --

Third -- I give to my daughter Margaret during her natural life a negro boy named Jim and after her death to the heirs of her body or dying without issue to revert to my Estate and be divided between my lawful heirs--

Fourth--I give to my daughter Frances during her natural life a Negro Girl Tena and her future increase and after her death

during her natural life all my Estate both real and personal after the payment of my just debts except so much as is herein specifically disposed of.
