First I give and bequeath unto my well beloved wife Polly Clinkscales the two several plantations known as the Home tract on which I now reside and the tract purchased by me from Bullock granted originally to Johnson also two negro men named Bob and Zack all of which is to continue in her poseefsion and enjoyment absolutely and without reserve till her death or marriage on. the condition that sall support, clothe and educate my minor children at her own expense she being entitled to their services until they respectively arrive at the age of Twenty one years giving to each of them a common English Education such as my other children received who have reached maturity and upon her death or marriage I desire my surviving Executor to sell the aforesaid property both real and personal in such manner and on such terms as may be deemed most advantageous to the estate and the proceeds divided among all my heirs equally. the portion to which my daughter Terissa Lanning may be entitled I desire to be invested or disposed of by my Executor in the manner most promotive of her interest and that of her children Secondly I give and bequeath unto my friend Amaziah Rice a negro girl slave named Sarah aged seven or Eight years and the increase of her body in Trust for the special use and benefit of my daughte Terissa Manning for and during her natural life and after her death to and for the use and benefit of her children to be distributed in such manner as would by Law in Case of her intestacy and to secure this purpose the Trustee is fully impowered

without further authority after her death to sell and execute
