I likewise to her a negro fellow named Adam and a woman named Hannah and her third child named (Henry, for and during her natural life and at her death to be sold and the proceeds therefrom to be eaqually devid between my Children at the time of Life hereafter mentioned. If however my wife Susan Harris & my lawful Ececutors think it hest to sell or in any way dispose of the above property they are at liberty to do so. And I also give to my wife Susan Harris a legacy of one thousand dollars to her, her heirs & assigns forever I give to my Son Edwin Handy Harris fifteen hundred dollars to be paid to him by my Executors when he arrives at the age of twenty one years.

I give to my Son George Reese Harris fifteen hundred dollars to be paid to him by my Executors when he arrives at the age eys due me on Nots & accounts. I give to my Son George Reese Harris fifteen hundred dollars to be paid to him by my Executors when he arrives at the age of twenty one years In adition to the above gift to my son George Reese Harris, I wish that portion of the income of the Estates not expended in the support of the family, to be used to defray the necessary expences in cured by him in getting his profession and the same paid by my Executors.

I give to my Daughter Mary S Harris a negro girl named Lucy & negro boy named Mat. and five hundred dollars to be given her by my Executors when she marry or when she is twenty one years

old. I give to my Daughter Lucsa Ann Harris three negroes to wit, George Alick and Jamima and likewise five hundred dollars to be given to her when she marrys or when she is twenty one year's old by my Executors.

The above named gifts to my Children I give to them, their heirs Executors & assigns forever.

All the rest of my property both real and personal of what nature or quality soever it may be, not herein before particularly mentioned and disposed of I desire to be sold and the proceeds arising therefrom I desire to be eaqually divided among my several children herein before named when they arrive at the above named ages or time of life to them their heirs ex

And lastly I do constitute and appoint my said wife Executrix and my friends David Cherry and Thomas R Cherry Executors of this my-last will and testament by me heretofore made.
