Wilson and for the Education of my Childred under the Care and Direction of My Executors till My son James Wharey Wilson Arives to the age of twenty or till the Time that he would be twenty one; if he ShoJld Die then and at that time it is my Will and Desire that all my Estate as aforesaid with all the increas Arising from the Same be Sold at Publice Sale to the Highest bidder Such Credit being Given as My Executors Shall think most Benifisial and the Money thence Arising to be Equally Divided into five Equal parts one to go to my Wife and the Other four parts to My four Children above Named a part for Each and if any of My Children Should die without Lawfull Isue their part or portion of My Eftate to be divided among the Rest of My Childred and the part or portion my Wife is to have She is to Enjoy Dureing her life and at her Death to be Divided among My Children aforesaid -- and I do also appoint and Request Thomas Wharey, John Wharey, and Stephen
