JOHN TURNER

In The name of God Amen I John Turner of the State of South Carolina and District of Barnwell being weak in Body but of sound and perfect mind and memory do make and Ordain this my Last will and Testament in manner and form following, First I would that my debts and Funeral Charges should be paid and discharged Item I give and Bequeath unto my Beloved Daughter Sarah Williams fifty acres of Land more or less being part ~~part~~ of a tract I purchased from William Minor and all that part lying on the North Side of the publick road my Son James Turner I have already given his his part on full Share of my Estate in cattle and a horse which he hath in possession and I hereby confirm the Gift, I give and Bequeath unto my Beloved Daughter Elizabeth Patterson one half of the Remaining part of the tract of land I purchased from Wm. Minor to be Equally Devided through the good and bad land that lies on the South Side of said publick Road Including her husbands Improvement and the other half of that part of the tract on the South Side of Said Road Together with forty Acres whereon I now live and my Crop^d, Bar^d, bay mare and Saddle and bridle I give and Bequeath to my Beloved Son William Turner I give and Bequeath unto my Beloved Daughter Verity Turner fifteen Dollars Cash and Establish in her the Right of the Cattle I Have already given her, I give and Bequeath unto my two Sons Joseph Turner & John Turner my Negro boy Humphrey and my young Roan horse Called Cullum and one Feather Bed and furniture to be Equally Divided between them; but if Either of the two last mentioned Should die under age or without Issue the Surviveing one to have the Joint Legacy I give and Be-

Minor to be Equally Devided through the good and bad land that lies on the South Side of said publick Road Including her husbands Improvement and the other half of that part of the tract on the South Side of Said Road Together with forty Acres whereon I now live and my Crop^d, Har^d, bay mare and Saddle and bridle I give and Bequeath to my Beloved Son William Turner I give and Bequeath unto my Beloved Daughter Verity Turner fifteen Dollars Cash and Establish in her the Right of the Cattle I Have already given her, I give and Bequeath unto my two Sons Joseph Turner & John Turner my Negro boy Humphrey and my young Roan horse Called Cullum and one Feather Bed and furniture to be Equally Divided between them; but if Either of the two last mentioned Should die under age or without Issue the Surviveing one to have the Joint Legacy I give and Bequeath unto my two Daughters Ihsannah Turner and mary Turner Each a Feather bed and Furniture and my Roadn mare and Colt with future Increase and all my household Furniture and Stock that may Remain at the Death of their Mother to be Equally Devided. The use of my plantation Roan Mare and Stock of Cattle plantation tools and house hold furniture I leave to my Beloved wife Mary ann Turner During her Natural Life and

then to be Disposed of as above Directed and Lastly I Appoint
my trusty and well Beloved Friends Mary ann Turner Executrix
and and my Son Wm. Turner and my Son John Turner to be my Exe-
cutors to this my Last will and Testament in Witnefs whereof
I have hereunto Set my hand Seal this Second Day of May 1806
