of my property that is Left to my Belov^d wife be Equally Di-
vided .. Between my own four Children Sarah Nathaniel Fashaw
& Family Long, & the six sons of Elizabeth Rowel Deceas^d.
James Levi Valentine David & Alford Rowel, Except my Negro
boy named Jack him I leave to be Equally divided between my
four Children Sarah/ Nathaniel Fashaw & Fanny at the decease
of my Beloved wife Sarah Long and I doe Nominate and appoint
my wife-- Sarah Long Executrix & Thomas Long. Sen^r & Thomas
Long Jun^r Executors to Execute this my last will & testament.
