

WILL OF

REDDIN CANNON

In the name of God Amen I Reddin Cannon of Barnwell District and state of South Carolina Planter, being of sound mind and memory, and calling to mind that it is ordained for all men once to die, do hereby make this my last Will and Testament, and I do hereby revoke, disanul and disallow all former Will or Wills by me made, and consider this as my only Will and Testament Imprimus The Plantation on which I now live I leave unto my beloved Wife, with full privilege to make use of any Timber on any part of my land. I also leave unto my beloved Wife a Negro Woman named Tamer, and her Two Children Charlotte, and Dinah with their Issue and Increase also a Negro Man named Tobey, and a Negro Man named York also Two Horses of which my said Wife is to take her choice and my riding Chair, also one half of my Household and Kitchen Furniture, and at her Death her part of the Furniture to divolve to my Daughter liza, the other part of my Household and Kitchen Furniture to be equally divided Between my Son Simeon Cannon. and my Daughter Eliza Cannon. I also leave unto my beloved Wife one half of my stock of Cattle and Hogs, and at her Death to belong to my Daughter Eliza and the other half of my Cattle and Hogs, and the remainder of my Houses I leave unto my Son Simeon Cannon Item. I leave unto My Son Simeon A Negro woman Named Hager and her Two Children affe and Ben with their future issue and increase and a Negroes fellow named Sambo. and a fellow named Nero. I also leave unto my Son Simeon all my other lands, the following excepted Five Hundred and Forty Four acres land granted to my Wife, also a Tract of Land Containing Five Hundred and Forty Four acres joining the Red Bluff. Two Hundred and Fifty Acres of

Wills by me made, and consider this as my only Will and Testament Imprimus The Plantation on which I now live I leave unto my beloved Wife, with full privilege to make use of any Timber on any part of my land. I also leave unto my beloved Wife a Negro Woman named Tamer, and her Two Children Charlotte, and Dinah with their Issue and Increase also a Negro Man named Tobey, and a Negro Man named York also Two Horses of which my said Wife is to take her choice and my riding Chair, also one half of my Household and Kitchen Furniture, and at her Death her part of the Furniture to devolve to my Daughter Eliza, the other part of my Household and Kitchen Furniture to be equally divided between my Son Simeon Cannon, and my Daughter Eliza Cannon. I also leave unto my beloved Wife one half of my stock of Cattle and Hogs, and at her Death to belong to my Daughter Eliza and the other half of my Cattle and Hogs, and the remainder of my Houses I leave unto my Son Simeon Cannon Item. I leave unto My Son Simeon A Negro woman Named Hager and her Two Children aff, and Ben with their future issue and increase and a Negro fellow named Sambo, and a fellow named Nero, I also leave unto my Son Simeon all my other Lands, the following excepted Five Hundred and Forty Four acres land granted to my Wife, also a Tract of Land Cont,g Five Hundred acres, joining the Red Bluff, Two Hundred and fifty acres of which, and the five Hundred and forty four acres above mentioned I leave unto my Daughter Eliza, I leave unto my Daughter Eliza, a Negro Woman named Jenny with her issue and increase, and the Negroes left to my Wife, after her Death they are with their issue and increase to belong to my Daughter Eliza, I do hereby nominate and appoint my beloved Wife as my executrix, and my friend David Delaach, and my son Simeon as my executors to this my last Will and Testament, In witness whereof I have

hereunto affixed my hand and Seal this Sixth day of April Eighteen Hundred and Eight, and in the Thirty Second Year of American Independence
