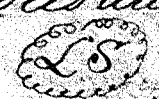


Pa 2 In the Name of God Amen. I Allan Sloan of St Thomas

 severally their heirs and assigns forever. Item I give devise and
 bequeath unto my beloved Wife Mary T Sloan all my Household and
 Kitchen furniture beds and bedding, my Silver Watch, my Mare Colt
 my riding Chair and Harness, and all the rest and residue and remainder
 of my Estate real and personal whatsoever and wheresoever to her, her heirs
 Executors and assigns forever. Lastly I nominate and appoint my said
 Wife Mary T Sloan sole Executrix of this my last Will and Testament
 hereby revoking all former Wills by me made, and publishing and declaring
 this to be my last Will. Witness my Hand and Seal hereunto set this
 eighteenth day of September in the year of our Lord one thousand
 eight hundred and thirty eight. A Sloan

 his presence and at his request have set our Names hereunto as
