Jane Hayden wholly and solely to do what she may think fit.
I request my friend James Casten Norris to act in this case as my Executor
and the friend of my Sister and in case of the death
of my Sister before my death what is given to her is
to be divided between her three Children Emma Jane
and Thomas Equally share and share alike and this Deed to be
put in force as soon as it is ascertained that I am no more which
