of the City of Charleston, being mindful of the uncertainties of Life, do hereby
make my Last Will and Testament in manner and form following
that is to say I will and direct that all my just and lawful debts due
at the time of my decease be fully paid and satisfied.

Item I Give and Bequeath to my Wife M^{rs} Elizabeth Jacoby
all the Household and Kitchen furniture I may leave at my de-
cease to belong absolutely to her.

Items I Give and Bequeath devise to my said Wife Elizabeth Jacoby
during the term of her natural life the Rents, use and enjoyment
of all my Real Estate: consisting of a House and Lot in Church Street
a House and lot corner of Cumberland and Church Streets and a Lot
with a Brick Tenement House thereon in Cumberland Street Charleston

and from and immediately after the death of my said wife, I give and Devise all and singular my above described Real Estate and all the same to my said daughter Sarah Jacoby her Heirs and assigns forever. It is my will that the Provision and Request herein made for my said wife, shall if accepted by her be taken and held in lieu and bar of all claims of hers on my said Real Estate and every part thereof.

Item It is my Will that all my negroes and other slaves, Stock in trade and other personal Effects shall be sold by such of my Executors as may qualify at Public auction immediately after my decease, upon such terms as may be deemed by them most advantageous: the proceeds of which sale, I do hereby direct my Executors to invest in Bank Stock or public Securities: the certificates of Stock to be taken in the name of my said Executors (or such of them as may qualify) in trust for my said Daughter Sarah Jacoby and I do direct my said Executors to apply so much of the Dividends and Income of such Stock and Securities as may be deemed by them necessary to the support, maintenance and Education of my said Daughter Sarah until she arrives at the age of twenty five years, upon the arrival of which time I do direct that the certificates of all such Bank Stock or Public Securities shall set in, and be transferred to my said Daughter Sarah Jacoby her Executors administrators and assigns forever, And it is further ^{my Will} that the surplus of such annual Dividends & Income which may remain after the payment of all expenses, allowing the support

remain after the payment of all expenses, attending the support
maintenance and education of my said daughter shall be in
like manner invested in stock and held and applied sub-
ject to the same uses and purposes as are above expressed.

Item. It is my will and I do hereby direct that all my
Bank Stock shall be held by my Executors or Trustees for my
said daughter Sarah Jacoby, the dividends to be applied if de-
emed necessary to the support and maintenance of my said daugh-
ter Sarah Jacoby and the Certificate to be transferred to her on
her attaining the age of twenty five years, at which time such Stock
shall be transferred to her as her absolute property. All the Rest
residue and remainder of my Estate, consisting of moneys due
on Judgment Bond, note, open account and any other kind of pro-
perty whatsoever, I do hereby direct, after being collected and received
by my Executors to be invested by them in Stock or loaned out on
Security of Real Estate or Trustees for my said daughter Sarah Jacoby
to vest absolutely in her on her attaining the age of twenty five years.
I do hereby appoint and constitute my Executors hereinafter named or
such of them as may qualify Guardians of the person and Estate of my
said daughter Sarah Jacoby and I do hereby direct them to take the
charge and superintendence of her maintenance and Education
And it is my desire that she shall be placed by my Executors or
of them as may qualify at Boarding or such Seminary as my
Executors may select, where she may receive the benefit of an
adequate course of instruction. And I do hereby

I do hereby appoint and constitute my Executors hereinafter named or such of them as may qualify Guardians of the person and Estate of my said Daughter Sarah Jacoby and I do hereby direct them to take the charge and superintendence of her maintenance and Education. And it is my desire that she shall be placed by my Executors or such of them as may qualify at Boarding in such Seminary or in such place as my Executors may select, where she may receive the benefit of an adequate course of instruction. And I do hereby nominate constitute and appoint for John W Schmidt, Jacob F Schmidt,

and George B. Eckhard. Executors of this my last Will & Testament hereby averring all former and other Wills by me heretofore made.
