 Robert Hume the Receipt Whereof I hereby Acknowledge & that James
 M. Alpine have bargained sold and Delivered and by these Presents in
 Plain and open Market according to the first of Jan Do bargain sell
 and Delivered unto the said Robert Hume the said Negro Boy named by Glasco
 to have & to hold the said Negro Boy unto the said Robert Hume his heirs
 assigns and assigns who his and their own proper Use and Behoof
 for Ever And I the said James M. Alpine the said Negro Boy unto the

and Robert Hume, his Executors, Adors and Assignors against all
 persons whomsoever shall and will Demand and for that Defeat by
 their Pleas Provided allways Nevertheless That if I the said
 M^r Albion my Heirs Executors or Adors or any of them shall do
 well and truly Pay or Cause to be paid unto the said Paul May
 his Heirs Executors or Assignors the full and just sume of one hundred
 fifty seven Pounds and three shillings good and Lawful M^o
 of South Carolina with Lawfull Interest for the same from
 Day of the Date of the said Pleas Obligations on or before the
 first Day of April which will be in the Year of our Lord
 thousand seven hundred and thirty one in full satisfaction
 Discharge of the said Pleas Obligations and also Do and
 from time to time and at all times hereafter well and sufficient
 save Defend and keep harmless and indemnified the said
 Robert Hume, his Heirs Executors and Administrators and any of the
