Perfect Inventory and Appraisement thereof and to Cause the same to
be returned under your Hands or any three or four of you into the
Mortgag Office in Charles Town in order to be Recorded on or before
the Twenty Eighth day of January next ensuing

Know all men by these Presents that I William Moore of the Parish of
Good Hope in the County of Berkeley in the Province of South Carolina for
Consideration of the sum of Two thousand and two hundred and fifty Pounds Current Money
of this Province to me in hand Paid at or before the Execution of these Presents by John Moore
of Charles Town in South Carolina Esq^r whereunto I acknowledge my self fully satisfied and
Paid and have and of Every Part thereof do hereby legally separate and Discharge the said
John Moore his Executors Administrators and Assignes for Ever by these Presents I the said W^m Moore
have granted bargained and sold and by these Presents do fully clearly and absolutely grant
bargain and sell unto the said John Moore and his Assignes all and singular the Negro
Slaves hereinafter Mentioned with their Increase and Produce that is to say
Briston Three Peter Jack Domo Kate Duke Little Prince and Limas & Mary
and to hold all and singular the said some Negroes heren before Particular named
with their Increase and Produce unto the said John Moore his heirs and Assignes To
the only proper Use and behoof of the said John Moore his heirs and Assignes for Ever
Provided always and upon this Condition that if the said William Moore my
Heirs Executors or Adminors do and shall well and truly Pay or cause to be Paid unto the
said John Moore his Heirs Executors or Adminors or Assignes the said Sum of Two thousand
Two hundred and fifty Pounds Current Money with Lawfull Interest for the same on or
before the first Day of March next ensuing the Date hereof without any man nor
of Default or Abatement whatsoever that then these Presents shall be void and of
none Effect otherwise to be and Remain in full force and Virtue AND I the said
William Moore for my self my Heirs Executors and Adminors do by these Presents given
Promise and Grant That if I the said William Moore my Heirs Executors and Adminors
shall make Default in payment of the said sum of Two thousand Two hundred and
fifty Pounds or Any Part thereof Contrary to the manner and form mentioned on the
above Provided then the said John Moore his Heirs Executors and Assignes shall and
may lawfully and quietly have hold and enjoy the aforesaid Acknowledged Slaves with
their Increase Produce and Appurtenances without any Lawfull Title Suit Trouble or
Molestation of the said William Moore my Heirs Executors Adminors or Assignes or of any other
Person or Persons whatsoever and further I the said William Moore for my self my
Heirs Executors and Adminors do hereby Demand Promise and Grant That I the said W^m
Moore my Heirs Executors and Adminors shall and will well and truly Pay or cause to
be Paid unto the said John Moore his Heirs Executors Adminors or Assignes the said Sum
