Executors hereinafter named In Trust to take such measures as
may be necessary to qualify them to enjoy the bequest and diversion
of all my Estate forever. And lastly I nominate constitute and
appoint Henry A Desaussure Edward W North and James S
Pelgrew Executors of this ~~my~~ Will and Guardians of the Infants
above named till they come of age with power to dispose of all or
any part of my Estate for the payment of debts or Execution of the
trusts aforesaid. And if any one of the Infants above named should
die under twenty one years without issue I give the whole to the
survivors In Witness whereof I have hereunto set my hand
this thirty first day of December in the year of Our Lord one thousand
eight hundred and thirty nine
