

In the name of God Amen, the Ninth Day of July, one thousand seven hundred & thirty two, I Alicia Ward Widow of Charles Town Being very Sick & Weak in Body but of Perfect mind & Memory Shakes do given unto God therefore Calling unto mind the Mortality of my body & knowing that it is appointed for all Mortals once to Die Do make & Ordain this my Last will & Testament that is to say Principally & first of all I give and Recommend my Soul unto the Hand of God that gave it & my body I recommend to the Earth to be buried in Decent Christian Burial at the Discretion of my Executors Nothing Doubting but at the general Resurrection I shall Receive the Same againe by the mighty Power of God to as Touching such Worldly Estates as it hath Pleases God to bless me in this life I Give Define & Dispose of the Same in the following manner

Imprimis I give & bequeath to my wellbelov'd Daughters Sarah Ward & Mary Ward one thousand Nine hundred & forty five Pounds New Shillings Current Money of this Province Due to me from my Son in Law William Lintwaite on a Bond Dated the Twenty fourth Day of June one thousand Seven hundred & thirty two with the Interest thereon Together with the Said Bond to be Equally Divided between my two Daughters Sarah Ward & Mary Ward ^{Each} one hundred Pounds Part thereof I Give to my Loving Daughter Eleanor Lintwaite & one hundred Pounds Part thereof to my Grand Daughter Anna Maria Lintwaite & one hundred Pounds to my Grand Son Thomas Lintwaite. **Item** I Give to my Loving Daughter Eleanor Lintwaite to my Grand Daughter Anna Maria Lintwaite I give my two Year Silver Cupp & two Daughters Sarah Ward & Mary Ward I give & bequeath all my Goods in the Shop pertaining to me whether bought in my Name or in the Name of my Daughters Sarah Each of them bearing an Equal Part in paying my Debts. **Item** I Give all my household goods & furniture to my three Daughters Eleanor Lintwaite, Sarah Ward & Mary Ward & the

Residue of my Plate & Jewels to my two Daughters Sarah & Mary. I also Give & bequeath my two Daughters Sarah & Mary Sole Executors of this my Last will & Testament

The Last Will & Testament of Joseph Meade

Joseph Meade of Berkeley County in the aforesaid Province being of Sound & perfect mind & Memory but being Sundry times Sick & considering the many Accidents & Dangers that we are on this Life Incident to Do think it proper & convenient to make my Last Will & Testament in Writing in witness whereof following first I Bequeath my Soul to God from whom I receive mercy & the Resurrection of my Soul through the merits of my Saviour Jesus to my body as it shall Please God to Dispose of it I will Ordain & Appoint that my just Debts be paid by my Executors hereafter Mentioned without Strife Contention or Contention whatsoever to as to the Worldly Goods which it hath Pleased God to bestow on me I Give & bequeath in manner & form following
