State of South Carolina. In the name of God Amen,
I, Joseph Glover M.D. of the City of Charleston & State aforesaid
with a mind sound both in memory & understanding (Thanks
be to God); Do make & publish this my last Will & testament in
manner & form following, viz; first; It is my will, that all my
just debts & funeral expences be paid as soon as possible out of
my Estate, & that it be kept together, until this be done.

Also, I give & bequeath to my wife Mrs Maria Glover in fee
simple to her, her heirs & assigns forever, the whole of the Estate, which
came to me by my marriage with her & of which I may be seized
or possessed at the time of my death; but it is not to be understood,
that in this bequest to my said Wife, I intend to give or include
my Salom Hope plantation near Parkers Ferry for having paid the
greater part of the purchase money for it, from my own funds, when
it was much depreciated in value, I consider it (as it has become by
purchase), my separate property. — Also I give & bequeath, to my
aforesaid Wife, her heirs & assigns forever, the choice of one of my Car-
riages & the choice of a pair of my Carriage Horses; the one third
part of my silver plate & the one third part of my house hold
& kitchen furniture, not otherwise specially devised; and also, the
use of the House & Lot N^o 6 Rutledge Street in which we now re-
side, for the period of twelve months after my decease, free of cost
or charge, on the express condition, nevertheless, that this & every other
bequest herein contained to my said Wife, be received by her, in
further lieu & bar of Dower & of all other claims.

having paid debts for her to a considerable amount I deem it unwise
or necessary to make any further provision for her. — Also I give & bequeath
to my daughter Miss Sarah W. Waring, the use of my
Yager Island & Anna West Plantations; together with the use
of my House & Lot in Gadsden Street, in which Dr. Charles Dwyer
now resides, during her natural life, & after her death, I will
divide & bequeath the same to her children, subject nevertheless to

limitation over, and shall be herein after expressed, with respect to the remainder of my Estate. Also I give devise & bequeath to my daughter Mrs Anna D Logan the use of my Berry Hill & Chisden plantation, together with the use of my House & Lot at the corner of Woutwath & Lynch Streets during her natural life & after her death, I will devise & bequeath the same to her Children, subject nevertheless to such limitation over, as shall be herein after expressed with respect to the remainder of my Estate. Also I give devise & bequeath to my son Edward Glover M.D the use of all those my lands on Ashepoo neck bounded to the east, by deer Creek, west & south west, by Mr Lowndes & Mr Vanderhorst; and north by Dr. Schmidt & the Cypress Plantation; (late Col. Cunninghams) & which I purchased from the Estate of Webb, of R Dewar & J Nutt, & which are designated in a plan thereof by Mr Detmoldt, as the Blessing plantation (in a part of the Swamp of which my Wife holds a life Estate); together with the use of my House & Lot on the east side of Lynch Street (in which Mr Ed Simons now resides;) during his natural life & after his death I will devise & bequeath the same to his Children; subject nevertheless to such limitation over, as shall be herein after expressed with respect to the remainder of my Estate. Also I give devise & bequeath to my daughter Mrs Elizabeth C Postell, the use of my Fallow hope plantation, near Parkers Ferry; together with the use of my House & Lot at the corner of Woutwath & Garden Streets, on which Mr Sire resides & the use of my six lots of land (on Charleston Neck, & above

the same course which I purchased from Judge Lee during her natural life & after her death, I will devise & bequeath the same to her children; subject nevertheless to such limitations over, as shall be herein after expressed, with respect to the remainder of my Estate.

Also I give devise & bequeath to my son Francis Y Glover M.D. the use of the whole of those my lands, on Fox pond neck, bounded to the east by Edisto River; to the west by deer creek; to the north & north west, by Dr Oswald & Mrs B Elliott; and to the south & south west, by the Estates of McPherson & Morris & C Jenkins; being composed of several tracts purchased of different persons, (in a part of the High Land of which my Wife holds a life Estate); together with the use of my house & Lot in which I now reside, on the east side of Rutledge Street; during his natural life, & after his death, I will, devise & bequeath the same to his children; subject nevertheless to such limitations over, as shall be herein after expressed with respect to the remainder of my Estate.) Also I give devise & bequeath to my five children, Mrs Sarah W Waring, Mrs Anna S Logan, I Edward Glover M.D. Mrs E S Postell & Francis Y Glover M.D. to each the use, of an equal portion of the remainder of my Estate, both real & personal, of whatever kind & wherever found of which I may die possessor, during their natural lives, to be divided equally between them share & share alike; and after their death, I give & bequeath, then several portions, a share to their children severally on their arriving at the age of twenty one years, simple, to them their heirs & assigns forever.

use, of an equal portion of the unencumbered of my Estate, both real
& personal, of whatsoever kind & wheresoever found of which I may
die possessor, during their natural lives, to be divided equally be-
tween them share & share alike; and after their death, I give
devise & bequeath, then several portions, a share to their children
severally on their arriving at the age of twenty one years, or
single, to them their heirs & assigns forever; provided nevertheless
in the event of either of my aforesaid Children dying

child or children so dying & leaving no issue shall be subject
to her, her or their disposal by their last Will & Testament, & if
one of my Daughters, as though she were a femme sole, & the power
is hereby given unto them: Also I will, that if either of my
said children should die intestate, & leave no issue, & leaving
issue they should die under age, in that event, give devise &
bequeath the use & her or their portions or shares to the
survivor or survivors of these my children just named, subject
nevertheless to the same limitation, over, as have been already
expressed, with respect to their own several & respective portions
of my Estate, devised & bequeathed unto them.

which they may contract, nor for the debts of their present nor
any future Husbands whom my Daughters may Marry; but shall
continue to vest & remain in them as herein before mentioned, &
with respect to my daughters, as though they were femme sole.

Also; it is my will that if either of my children or any one
under them, shall dispute my right to dispose of my Younger's In-
land plantation, as I have done; or shall litigate the division
of it.

Francis V. Glover M.D. to be the Executors of this my last Will &
testament & in the event of the death of either of them I appoint

I give my Silver Casket which bears the initial, of the name of my Mother to them their heirs & assigns forever. Lastly, I nominate & appoint my sons J. Edward Glover M.D. & Francis G. Glover M.D. to be the Executors of this my last Will & Testament & in the event of their deaths or refusal to act, I then further nominate & appoint my son in law, George W. Logan Esq. my Brother Henry C. Glover M.D. and my friends, Francis G. Precher M.D. & Dr. J. D. Logan

the year of our Lord one thousand eight hundred & thirty eight.

A Codicil to my last will & testament viz (dated 22 March 1838) I will & bequeath to my wife Mrs Maria Glover, the sum of one thousand dollars, from the proceeds of my crop to be made from the Snuggetts plantation, in further lien & bar of her right of dower or dower or of any other claims whatsoever out of my Estate.
